Agenda Item Four: Senior Competition Format

#### a. Preseason Competitions (Fast Hockey)

The first two weeks of senior hockey will be a preseason competition (Fast Hockey) and will be held on the 18<sup>th</sup> March and 25<sup>th</sup> March. The format of the Preseason Competition will be decided by the MVHA Joint Match Committee but looking at short games on a round robin system – This will be non-compulsory and clubs to enter teams in whatever division that they think the team will be competitive. We will not be sure how many teams will participate in this preseason fast hockey. Clubs will need to supply umpires for the games. Team Nominations and the grade they wish to nominate for Fast Hockey matches will be due by the 16<sup>th</sup> March 2017

Motion: "A non-compulsory Senior Pre-season Competition will be played on Sat 18<sup>th</sup> and 25<sup>th</sup> March in a format to be advised".

#### b. Premier League

Much discussion took place on the structure and timing of a Premier League Competition.

The Match Committees will decide on the format of the competition. The draws for the Premier League will be set done by the Match Committee when registrations are received".

#### c. Allocation of turf times

The meeting saw the need for equity in allocating turf times across all grades.

During normal round matches of MVHA all teams no matter what division or sex will be allocated playing times evenly with no favour towards time slots.

If Port Macquarie women's teams are entered in the competition the same considerations will be given".

The meeting agreed that it was prudent to have the guardians of junior players playing in the MVHA Senior Hockey Competition sign an age waiver for their child.

Motion: "Junior players under the age of eighteen should sign and players under fifteen (15) MUST sign an age waiver as presented by the President to the meeting. Clubs to indicate on the Team Registration Forms the names of the players who are required to do so and attach waivers to the Registration Form"
