- Gloucester Mix up with Lachlan Howard – Please provide proof that the Manning Valley fee has been paid otherwise it will be regarded as forfeit for playing an unregistered player. If the player is unregistered then in accordance with Clause 4B of the playing rules the match will be a forfeit form Gloucester.
- Port Macquarie change is in accordance with the playing rules

 - Round 12 Sharks Vs Wingham will be played at 7pm 25/7/2018 on turf 3 - Umpires Tigers and Taree West Tech duty Wingham.
 - Round 13 Sharks vs Taree West will be played on the 7/8/2018 on TLF - Umpires Wingham and Chatham tech sharks.

CORRESPONDENCE MOVED BY LINDA FERGUSON 2ND BY DYLAN TURNER

GENERAL BUSINESS

- A discussion around the revision of the current playing rules took place. It was concluded that the SMC is not the appropriate place for changes to the current playing rules to be occurring. A request is to be sent to the board to ask that a rule committee to revise the current rules and make required amendments be a priority to ensure that the rules are in place early for the 2019 season.
- 50% plus 1 rule was discussed – particularly regarding divisions with byes, after lengthy reading of the rules including the terms of reference it was concluded that games played is what the 50% plus 1 should be based on not the actual rounds – eg division 1 women have 20 rounds but only play 16 games so therefore 50% plus 1 will be 9 games.
- It was also concluded that if you are a NF player and play 50% plus 1 the player then becomes a frozen player in that division. Eg A NF1 player plays 9 games in division 1 so then becomes a F1 player.
- The above was brought up at the last meeting however not clarified and therefore may have caused some clubs to already have broken these rules due to the uncertainty around what constitutes 50% plus 1. Any teams having a player participate in a game that breaks the 50% plus 1 rule as clarified at this meeting will lose points and the game be considered a forfeit from matches on and after Thursday 12/7/2018. **It is the responsibility of Match Committee delegates to ensure that their clubs are aware of this rule clarification and the enforcement of losing points if the rules are not adhered to.**
- Jamie Hemmingway is listed as a F1 player in Chatham's playing list and has not played a game, so an email will be required to be sent to Chatham requesting that they remove her and replace her with another player.
- A query was placed on a division 4 card requesting clarification of Sandra Tran's eligibility to play division 4. Sandra Tran is a F4 player in Sharks playing lists and is therefore eligible to play in division 4.
- Tiger hockey club have played 3 non frozen players on 2 occasions on the 21st and 8th April as their players were listed on their frozen lists at the time. In accordance with the rules they therefore forfeit the two matches.
- Nicole Clark discussed best and fairest points regarding unfrozen and frozen players receiving eligibility to receive points. A lengthy discussion occurred as the rule 19 H(c) says that best and fairest points be awarded across all players on the field it was concluded that the best and fairest points shall be recorded from this point on in accordance with this rule.

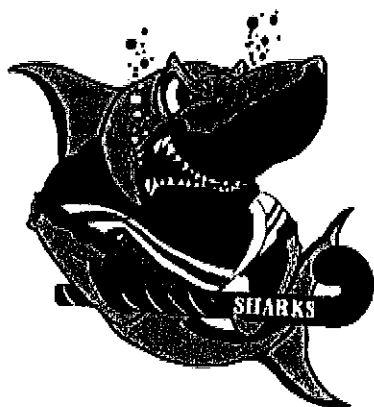

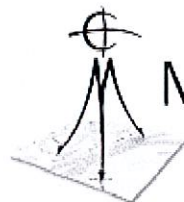
