#### MVHA Presidents Report: Season 2020

#### To all MVHA members

Season 2020 – I don't think anyone in their wildest dreams could ever have predicted the year we just had. Covid 19 made sure that my final year at the helm of MVHA was memorable.

This report will be a brief review of the season and also a chance for me to formally thank everyone for their ongoing support for MVHA.

The 2020 season, proved that we are a very adaptable and committed association. MVHA adapted to the situation and rules created by the pandemic and created a safe, short but sweet competition. Our participation numbers held and we managed to hold 3 division competitions in Men and Women and a fantastic junior competition from 7s to 15s. Congratulations to all the clubs and teams.

I want to sincerely thank all the current Clubs and members of MVHA. Even though you were disappointed that the season was not like other years, you stuck with hockey, you embraced the season that we could play and committed to making it a success. It was amazing to be part of.

To all the Presidents and club executives, Senior and Junior Match Committee members, Coaches and umpires. You were amazing and flexible continually adapting and moving with the near weekly changes. Keeping your members and players safe and informed and working together with the board to give the players a viable competition. Well done!

To Rod Collier, thank you for again stepping up and running Minkey, also having to change and adapt on a weekly basis.

Apart from the disruption of Covid, 2020 was also my last year as President of MVHA. My time as president (4 years) has been a fantastic, fulfilling, extremely busy and sometimes frustrating experience, but one I am grateful to have had the chance to have. I am so thankful for and proud of the MVHA board members I have worked with over the years. They are a truly committed bunch of hockey tragics and MVHA is all the better for it.

As a small rural association I believe we have achieved a lot, I would like to highlight some general achievements.

- 1. MVHA is now a united association. With member input and consultation we have integrated our men's and women's with all players playing under the same rules. Juniors have also had a revamp of rules to standardise playing conditions. We have begun formal governance with written processes, meeting charters and business plans put in place so everyone knows the expectations of committees. This process is ongoing but a start has been made.
- 2. MVHA has further enhanced their facilities in the last 4 years. We now have 3 completed turfs with scoreboards and the clubhouse is fully fitted out. We have converted the lights to full automation using pin codes. Over the break the safety fence at the ATF and 3<sup>rd</sup> turf have also been redone. There is always more we can do, and we will continue to do in the future to maintain, preserve and improve our facilities and turfs.
- 3. MVHA have been active in promoting and growing our indoor hockey competitions and increasing exposure to all players by starting up Summer Hockey. Our indoor has run for the last 3 years and was growing in popularity, until Covid. Thanks to our committed members, particularly Scott Harry, we still run last year in a modified comp.

- 4. Last year MVHA also restarted Summer Hockey. This was billed as non-competitive/ openish age no skill or previous hockey experience required game. This concept and format received positive feedback from participants. This format highlights the amazing accessibility and possibility of our sport where Mum's, Dad's kids and grandparents could play together a team sport together in a safe, fun, supported environment. My hope is that this remains an end/ beginning of season option to help grow our sport and increase participation from a wider range of people.
- 5. Over the last 4 years MVHA has held at least one successful HNSW championship per year, and competed in all age groups. Although I must admit being on sewerage watch during the under 15 girls was not so much of a highlight!! MVHA will continue this tradition with 2 championships this year. In June we will host the over 55 Men's Masters and in July the HNSW half state Women's masters. Every Championship we held even the sewerage marred one we received praise and positive feedback and that is due to our amazing MVHA clubs and their volunteers making them a success.

Now the BOM members. I mentioned briefly earlier, hockey tragics and totally committed to our members and hockey. I cannot speak highly enough of their work ethic, stamina, patience and dedication.

John, Doug and LT were my rocks when I first began in the position. Amazing fun and hardworking they helped me immeasurably and I was so lucky to have had their guidance during my tenure.

Shane maintaining the turfs and being available to be a presence at the clubhouse for any services needing access.

Dylan was also involved in the indoor competition and a link to the representative responsibilities and RCC for the association.

Newer members who have stepped either back on to the board or on for the first time, Lynne, Jason, Kevin, Terry and Loretta. All essential to the board functioning holding many roles and always willing and able to step up and help at any time.

A special mention to Shelly Collier MVHA VP and Ruth Sheather, two people I am lucky to call my friends. Both amazing support and help to me. The work they did behind the scenes and their unwavering support has enabled me to continue in this position.

Along with the board members there is also a group of silent volunteers that work quietly without seeking attention for their efforts. They don't seek recognition so I won't name them but I would just like to thank them for their ongoing work in supporting the Board and MVHA. Their work is much appreciated and without them we would not have the facilities maintained.

Also, I could not have done this position without support at home. Di my partner has been very supportive of me doing this role. It has taken up a lot of time after work and on weekends for the last 4 years, so without her understanding, support and advice I could not have committed myself to the role as much as I did.

Finally all the members and their families. Thank you all for your support, suggestions and encouragement. We all love this game of hockey and want it to continue to grow and succeed. What an interesting Covid 19 year we have had!

I have enclosed a Profit and Loss report with this brief outline of our 2019/20 Hockey year.

Our main outgoing cost this year were the three scoreboards which were replaced at a cost of \$39,976.20.

We were not able to have our bar running due to Covid and we also limited some of the items we sold in the Canteen. Our team numbers were down, in fact one club decided to pull out of the competition altogether.

Considering the above I think we did reasonably well to only have a loss of \$26,282.83 considering the cost of the scoreboards.

At the end of November 2020 (not the 2019/20 financial year) we also had an expense of almost \$10,000.00 for repair and replacement of some our lights on the ATF. This amount was almost doubled on the original invoice but with many phone calls and selling of souls we managed to get this down by almost half. The large costs were mainly because they need to get a private crane in to change the lights as they cannot use their "cherry picker". MCC have suggested we apply for a grant to replace the electricity poles on the ATF to steel poles and change all our lights to LED as they only need replacing every 10-years (approximately).

Manning Valley Hockey held up well during an exceedingly difficult Covid 19 year. We were able to run a competition, albeit with reduced weeks and still meet our financial commitments and pay our loan each month.

I understand we have someone who is willing to take over the Treasury position for the 2020/21 year so I will graciously step aside from this position.

I would like to thank the BOM management for their help and guidance, especially Ruth Sheather, Michelle Collier and Doug who have been most helpful.

I wish the new BOM all the best for the new hockey year. Thank you. Loretta Bennett.
