#### VI. General Business:

1. Deferment outcome for B-grade men's match Sharks v Gloucester May 14th

Approved – Match rescheduled for Saturday 16th July at 7pm on ATF

2. Deferral Request Wingham Division 3 women's Saturday 21st May at 1pm:

Two players selected in the U18s Manning Valley team, current request does not meet criteria (Selected players: McKenzie Chapman and Asha McLeod).

#### 3. Mid North Coast Hockey League match timing:

Robust discussion regarding timing decisions made at MNCHL meeting, of impression that decision was made to play 17 minute quarters with 1 minute for quarter time and 5 minutes for half time with no time out for penalty corners.

MNCHL committee has directed that the rules state 15 minute quarters with 2 minutes for quarter time and 5 minutes for halftime, with no time out for penalty corners.

Moving forward MNCHL rules will be applied with Tony Lewis to email MNCHL committee with match committee feedback regarding timing, hooter, preferences etc.

## 12. Clarification provided regarding capacity for MNCHL teams having the capacity to draw on players from other clubs for MNCHL matches, whom do not have a division 1/MNCHL team:

Current Manning Valley Hockey playing rules do not facilitate cross club play. The MNCHL rules currently outline that your associations rules regarding playing across clubs determines eligibility.

This is not the same as Port Macquarie's playing rules. Follow up for next season to ensure equity moving forward regarding this.
